

## THE TERMS OF THE AGREEMENT

### 1. Provision of information by the Client:

1.1. When registering on the site code-pilots.ru (hereinafter - the "Site") the Client provides the following the information: a surname, a name, a patronymic of the recipient; the city and the address for delivery of the Order; contact phone number.

1.2. By providing your personal data, the Client agrees to their processing (up to revocation of the Client's consent to the processing of his personal data) by the company LLC

"ACE solutions" located at the address: 191119, Dostoevsky street, 44, of. 402 (hereinafter -

"Seller"), in order to fulfill the obligations of the Seller and/or its partners to customer, sales of goods and services, provision of reference information, and in order to promote goods, works and services, and agrees to receive advertising and information messages and service messages. In the processing personal data of the Customer the Seller is guided by the Federal law "On personal data", the Federal law "On advertising" and local regulations documents.

1.2.1. If the Client wishes to clarify his personal data, their blocking or destruction if personal data is incomplete, out of date, inaccurate, illegally obtained or not necessary for the stated purpose processing, or in the case of the client's desire to withdraw his consent to the processing of personal

If the Customer wishes to delete his account on the Website, the Customer shall contact us by

withdrawal of the client's consent to the processing of his personal data, which according to

to the current legislation occurs in the order provided by the paragraph 1 this paragraph.

### 1.3. Use of information provided by the Client and received by the Seller.

1.3.1 the Seller shall use the data provided by the Client for the entire period of time.

- to carry out activities to promote goods and services;
- evaluation and analysis of the Site;

- participation in customer loyalty programs ;
- informing the client about new articles, news, promotions, discounts and special offers offers through e-mail and SMS-mailings.

1.3.2. The seller has the right to send messages to the Client advertising and information

reasons. Service messages are sent to the e-mail address,

specified when registering on the Website and through SMS messages and/or rely and via Service work with clients on the phone number specified when registration and/or when placing an Order, the status of the Order, the goods in the customer's cart.

2. Provision and transfer of information received by the Seller :

2.1. The seller undertakes not to transfer the information received from the Client to third parties.

It is not considered a violation of the provision of information by the Seller to agents and third parties,

acting on the basis of the contract with the Seller, for the performance of obligations to

The client and only within the framework of contracts. It is not considered a violation of this paragraph transfer

By the seller to third parties of the Client's data in an anonymised form for the purpose of evaluation and analysis

Site work, analysis of customer characteristics of the Client and the provision of personal recommendations'.

2.2. It is not considered a violation of the obligation to transfer information in accordance with

reasonable and applicable requirements of the legislation of the Russian Federation.

2.3. The seller has the right to use cookies. Cookies do not contain confidential information and not disclosed to third parties.

2.4. Seller receives information about your IP-address of the site visitor code-pilots.ru and information about Tom, the link from which website the visitor came. This information is not used to identify the visitor.

2.5. The seller is not responsible for the information provided by the Client on the Website public form.

2.6. When processing personal data, the seller accepts the necessary and sufficient organizational and technical measures to protect personal data from illegal access to them, as well as from other illegal actions in relation to personal data.

### 3. Storage and use of information by the Client

3.1. The client undertakes not to disclose to third parties the login and password used by him for identification on the website code-pilots.ru.

3.2. The customer undertakes to ensure due diligence in storage and use login and password (including but not limited to: use licensed anti-virus programs that use complex alphanumeric combinations when creating a password, immediately change the password after automatic registration, notification of which comes to the client's e-mail, not to make available to third parties computer or other equipment with the client's login and password entered on it)

3.3. If the Seller has any suspicions about the use of the account customer records by a third party or malicious software Vendor the right to unilaterally change the client's password
